- **Annual Title I Meeting**

Britton Elementary will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, parents' requirements, the school parent and family engagement policy, and the school-parent compact.

*Britton Elementary will hold its Annual Title I Meeting on October 24<sup>th</sup>, 2023 at 4:30 p.m. and 5:30 p.m. An email invitation will be sent to the guardians of each student receiving Title I services with a follow-up paper invitation sent home in reading bags. Britton Elementary provides an agenda for their presentation and interpreters for Arabic and Spanish speaking families. The purpose of the meeting will be to disseminate information about the Title I program specifically offered at Britton Elementary School.*

- **Communications**

Britton Elementary will take the following actions to provide parents of participating children the following:

- Timely information about the Title I programs;
- Flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, child care or home visits, as such services relate to parent and family engagement; and
- Information related to the school and parent programs, meetings and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand.

*Britton Elementary primarily uses email, but depending on the needs of the family, written notes sent home in the child's reading bag, paper invitations, and phone calls are also used. To aid in the communication with non-English speaking parents, talking points technology applications and interpreters are used.*

*Stephanie Borlaza, principal of Britton Elementary states, "I encourage teachers to communicate directly with parents with specific information about the child's needs and the specific home-actions that can support growth. Teachers are encouraged to make positive phone calls home, provide positive handwritten notes, as well as communicate via phone and email throughout the year."*

- **School-Parent Compact**

Britton Elementary will take the following actions to jointly develop with parents of participating children - a school-parent compact that outlines how parents, the entire school staff and students will share the responsibility for improved student academic achievement and how the school and parents will build and develop a partnership to help children achieve the state's high standards.

*As soon as students are assessed at Britton Elementary and a rank order student list of eligible students is created, the classroom teacher and/or the Title teacher will place a call to the parents to explain how Title services work. Parents are informed of the upcoming Title I informational meeting. At this meeting a school-parent compact will be distributed to parents and a short presentation will follow that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement. Parents will be asked to return the compact (with the required signatures) to their child's Title reading teacher. Title teachers will follow up with parents who do not return them.*

- **Reservation of Funds (applicable to districts with Title I allocations of \$500,000 or more)**  
**Britton Elementary** will take the following actions to involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parent and family engagement is spent.

*Stephanie Borlaza, principal of Britton Elementary, is aware that the Hilliard City School District is a district that is allocated \$500,000 or more in funding and must reserve 1 percent of their funding for parent and family engagement. At the second Parent & Family Engagement Committee meeting, “Reservation of Funds” is an agenda item. Stephanie will explain “Reservation of Funds” and share a list of how Britton Elementary currently uses this money for parent and family engagement activities and programs, as well as, gather input into how the funds might be used in other ways.*

- **Coordination of Services**  
 Britton Elementary will, to the extent feasible and appropriate, coordinate and integrate parent and family engagement programs and activities with other federal, state, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children.

*Britton Elementary on the BNLC Campus works closely with our Community Partners, including the Columbus Public Library, Columbus Zoo, Norwich Township Fire, and Hilliard Police to provide students with opportunities for engagement that extends beyond the classroom and school. We also partner with Nationwide Children’s Hospital, Ohio State Mobile Dentist, and the State of Ohio iSee with Vision to Learn program, to provide on-going wellness opportunities to parents and students. We work closely with our Syntero partners to provide on-going mental health support and counseling.*

- **Building Capacity of Parents**
  - Britton Elementary will build the parents’ capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:
  - Provide parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress and the achievement levels of the challenging state academic standards;
  - Provide materials and training to help parents work with their children to improve their children’s achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement; and
  - Provide assistance to parents of participating children, as appropriate, in understanding topics such as the following:
    - The challenging state’s academic standards;
    - The state and local academic assessments, including alternate assessments;
    - How to monitor their children’s progress; and
    - How to work with educators to improve the achievement of their children.

*Teachers at Britton Elementary communicate academic progress officially every twelve weeks at progress report time. Title teachers have a folder in which they send daily communication in written form to parents, which allows for parents to write back. This is a great way for teachers to keep parents informed about ongoing progress and is another way that teachers help parents understand how to work with their children at home.*
