Treasurer Report: Anne Zavaglia

- Statement of Financial Position distributed.
- Total Davidson checking balance stands at \$92,347.52. Does not include recent deposits. There is additional income from Tag Day online donations, money from Hilliard Invitational and concessions that have not been pulled from Square account and deposited yet.
- Total income YTD is \$55,700.61, but does not include several deposits that still need to be made..
- The Statement of Activity currently shows a negative net revenue of \$14,671.27, but not all deposits have been made, which will adjust the net revenue.
- Gross concessions profit for the year so far is \$5975.80. This does not reflect the money that is in the Square account, which will significantly increase this amount once deposited.

Secretary Report: Brenda Garrett

• Minutes from the meeting held on September 12, 2023 were sent to Mr. Shultz to be uploaded to the website for reference. A copy of the minutes from this meeting were distributed to those in attendance. No questions or corrections were raised during the meeting.

 - Kelly Goffigan will be handling tuxedo fittings this week and she has help to complete the fittings.
