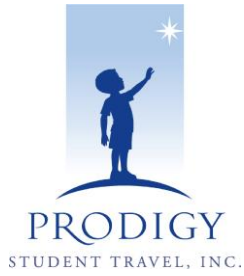
* The following is the planned payment schedule (after deposit). These payments can be paid online or sent directly to Prodigy Student Travel by the following due dates:

**Fri., May 23, 2025: \$175 due
Fri., June 27, 2025: \$175 due
Fri., August 1, 2025: \$175 due
Fri. September 12, 2025: \$175 due (final payment)**

INDIVIDUAL REFUND POLICY:

1) \$150 deposit is non-refundable, 2) Beyond the non-refundable portion, as of 8-14-25, portion of trip costs refundable to PST will be refunded to customer if PST is notified up to 30 days before departure date, 3) refunds requested to PST within 30 days of departure date will be made at the discretion of Prodigy Student Travel.

**** IF THE SCHOOL DECIDES TO CANCEL THE TOUR FOR SECURITY REASONS AT ANY TIME THRU 8-14-25, EACH STUDENT WILL RECEIVE A 90% REFUND OF THE TOTAL TRIP PRICE (\$765), MEANING PST WILL RETAIN \$85 PER STUDENT. SCHOOL CANCELLATION AS OF 8-15-25 WILL RESULT IN AN 88% REFUND OF THE TOTAL TRIP PRICE (\$748), MEANING PST WILL RETAIN \$102 PER STUDENT.**
