## 2025-26 Credit Flexibility Application COURSE PROFICIENCY



Credit flexibility provides students within the Hilliard City School District with an alternative method for earning high school credit. Recognizing that some students have advanced skills and/or special interests in particular content areas, credit flexibility provides a venue for demonstrating learning and proficiency — thus allowing students to earn credit and/or move into more advanced coursework, bypassing previous "seat time" requirements.

Updated: July 2025

Credit flexibility encourages student self-direction and motivates learners to develop new skills and fulfill their potential. It also recognizes that, while learning experiences must be high quality, not all learning happens inside the classroom or in formal education settings.

## Please note that per the Credit Flexibility Course Proficiency Guidelines:

- O Credit will be issued for an assessment score of 70% or higher.
- A score below 70% will result in an "F" on the student's official transcript.

## **Guidelines for COURSE PROFICIENCY Credit Flexibility:**

**Approved for Credit Flexibility Option:** 

- 1. All courses listed in the Hilliard City Schools' High School Program of Studies are eligible for the credit flexibility option.
- 2. The completed application for Course Proficiency Credit Flexibility must be submitted by the following deadline(s): **October 3** (for the December assessment); **March 6** (for the May/June assessment); **May 1**(for the August assessment).
- 3. The completed application should be submitted to the guidance office.
- 4. A letter will be mailed home confirming receipt of the application.
